Guide to International Evaluation Companies for Undergraduate Applicants

Transcript evaluations are required for all college level work completed outside of the US. High school transcript evaluations are also required for international freshman applicants and for transfer applicants who have earned less than 24 hours (1 year) of college credit. Transcript evaluations will be accepted from any NACES accredited evaluation agency. Evaluations must be **course-by-course**, official, and sent directly from the evaluation company to Belmont at: Office of Admissions, Belmont University, 1900 Belmont Blvd., Nashville, TN 37212

Below is a list of suggested evaluation agencies with information about different evaluations and costs.

OPTIONS FOR SECOND DEGREE OR TRANSFER APPLICANTS WITH AT LEAST 24 HOURS (~1 YEAR) OF COLLEGE LEVEL WORK

Students who have completed at least 24 hours of college work at a university ONLY need to submit evaluations of their college-level work.

<u>WES ICAP</u>- \$205: Includes verified transcripts and evaluation report stored and ready to be sent to education institutions. This is a good choice for students who have limited official copies of their transcripts because they will remain on file with WES.

WES Basic-\$160: Accepted by Belmont. This only includes evaluation report. Does not include official transcripts.

Transfer students who have completed less than 24 hours of college work must submit course-by-course evaluations of BOTH their high school transcripts AND their college transcripts.
